

**AMENDMENT TO H.R. 5658, AS REPORTED
OFFERED BY MR. SPRATT OF SOUTH CAROLINA**

Strike section 1224 of the bill and insert the following:

1 **SEC. 1224. REQUIREMENT TO UPDATE NATIONAL INTEL-**
2 **LIGENCE ESTIMATE ON IRAN'S NUCLEAR IN-**
3 **TENTIONS AND CAPABILITIES.**

4 (a) **REQUIREMENT.**—Not later than 180 days after
5 the date of the enactment of this Act, and annually there-
6 after, the Director of National Intelligence shall submit
7 to Congress an update of the National Intelligence Esti-
8 mate, entitled “Iran: Nuclear Intentions and Capabilities”
9 and dated November 2007. Such update may be submitted
10 in classified form.

11 (b) **ELEMENTS TO BE CONSIDERED.**—Each update
12 submitted under subsection (a) shall include the following:

13 (1) The locations, types, and number of cen-
14 trifuges and other specialized equipment necessary
15 for the enrichment of nuclear material and any plans
16 to develop and operate such equipment in the future.

17 (2) An estimate of the amount, if any, of en-
18 riched to weapons-grade uranium materials acquired
19 or produced to date and plutonium acquired or pro-

1 duced and reprocessed into weapons-grade material
2 to date, an estimate of the amount of plutonium
3 that is likely to be produced and reprocessed into
4 weapons-grade material in the near- and midterms
5 and the amount of uranium that is likely to be en-
6 riched to weapons-grade levels in the near- and mid-
7 terms, and the number of nuclear weapons that
8 could be produced with each category of materials.

9 (3) A description of the security and safeguards
10 at any nuclear site that could prevent, slow, verify
11 or monitor the enrichment of uranium or the reproc-
12 essing of plutonium into weapons-grade materials.

13 (4) A description of the weaponization activi-
14 ties, such as the research, design, development, or
15 testing of nuclear weapons or weapons-related com-
16 ponents.

17 (5) A description of programs to construct, ae-
18 quire, test, or improve methods to deliver nuclear
19 weapons, including an assessment of the likely
20 progress of such programs in the near- and mid-
21 terms.

22 (6) A summary of assessments made by other
23 allies of the United States of Iran's nuclear weapons
24 program and nuclear-capable delivery systems pro-
25 grams.

1 (e) NOTIFICATION.—The President shall notify Con-
2 gress, in writing, within 15 days of determining that—

3 (1) the Islamic Republic of Iran has met or sur-
4 passed any major milestone in its nuclear weapons
5 program; or

6 (2) Iran has undertaken to accelerate, deaccelerate,
7 or cease the development of any significant
8 element within its nuclear weapons program.
