3 “(g) INAPPLICABILITY TO CERTAIN PROGRAMS.—

4 The provisions of this section shall not apply to the Na-

5 tional Intelligence Program, the Joint Military Intelligence

6 Program, and Tactical and Related Activities unless such

7 program or an element of such program is designated as

8 a National Drug Control Program—

9 “(1) by the President; or

10 “(2) jointly by—

1 “(A) in the case of the National Intel-
2 ligence Program, the Director and the Director
3 of National Intelligence; or

4 “(B) in the case of the Joint Military In-
5 telligence Program and Tactical and Related
6 Activities, the Director, the Director of Na-
7 tional Intelligence, and the Secretary of De-
8 fense.”; and

9 (2) by amending subsection (h) to read as fol-
10 lows:

11 “(h) CONSTRUCTION.—Nothing in this Act shall be
12 construed as derogating the authorities and responsibil-
13 ities of the Director of National Intelligence or the Direc-
14 tor of the Central Intelligence Agency contained in the Na-
15 tional Security Act of 1947 (50 U.S.C. 401 et seq.), the
16 Central Intelligence Agency Act of 1949 (50 U.S.C. 403a
17 et seq.), or any other law.”.

Page 151, line 14, strike “(j)” and insert “(k)”.
