A BILL

To amend the Wild and Scenic Rivers Act to designate a segment of the Missisquoi and Trout Rivers in the State of Vermont for study for potential addition to the National Wild and Scenic Rivers System.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Missisquoi and Trout*
5 *Rivers Wild and Scenic River Study Act of 2008”.*

6 **SEC. 2. DESIGNATION FOR STUDY.**

7 *Section 5(a) of the Wild and Scenic Rivers Act (16*
8 *U.S.C. 1276(a)) is amended by adding at the end the fol-*
9 *lowing:*

10 *“(____) MISSISQUOI AND TROUT RIVERS,*
11 *VERMONT.—The approximately 25-mile segment of the*
12 *upper Missisquoi from its headwaters in Lowell to the Ca-*
13 *nadian border in North Troy; the approximately 25-mile*
14 *segment from the Canadian border in East Richford to*
15 *Enosburg Falls; and approximately 20 miles of the Trout*
16 *River from its headwaters to its confluence with the*
17 *Missisquoi River.”.*

18 **SEC. 3. STUDY AND REPORT.**

19 *Section 5(b) of the Wild and Scenic Rivers Act (16*
20 *U.S.C. 1276(b)) is amended by adding at the end the fol-*
21 *lowing:*

22 *“(19) MISSISQUOI AND TROUT RIVERS, VERMONT.—*
23 *Not later than 3 years after funds are made available to*
24 *carry out this paragraph, the Secretary of the Interior*
25 *shall—*

1 “(A) analyze the potential impact of the designa-
2 tion on private lands within the Missisquoi and
3 Trout Rivers, Vermont, described in subsection
4 (a)(____) or adjacent to that area;

5 “(B) complete the study of the Missisquoi and
6 Trout Rivers, Vermont, described in subsection
7 (a)(____); and

8 “(C) submit a report describing the results of
9 that study to the appropriate committees of Con-
10 gress.”.
