

AMENDMENT TO H.R. 1388, AS REPORTED
OFFERED BY MR. ROSKAM OF ILLINOIS

In the table of contents in section 1(b) of the bill, strike the item relating to section 1601 of the bill and insert the following:

“Sec. 1601. Family and medical leave and reports.”.

In section 1513 of the bill, strike paragraphs (1) and (2), and redesignate paragraphs (3) and (4) as paragraphs (1) and (2), respectively.

Amend section 1601 of the bill to read as follows:

1 **SEC. 1601. FAMILY AND MEDICAL LEAVE AND REPORTS.**

2 (a) **FAMILY AND MEDICAL LEAVE.**—Section
3 171(a)(1) (42 U.S.C. 12631(a)(1)) is amended by striking
4 “with respect to a project” and inserting “with respect
5 to a project authorized under the national service laws”.

6 (b) **REPORTS.**—Section 172 (42 U.S.C. 12632) is
7 amended by adding at the end the following:

8 “(d) **EVALUATION USING PROGRAM ASSESSMENT**
9 **RATING TOOL.**—

10 “(1) **STUDY.**—The Director of the Office of
11 Management and Budget shall conduct a study to
12 evaluate the programs authorized by this Act, in-

1 including the amendments made by this Act, under
2 the Program Assessment Rating Tool or a successor
3 performance assessment tool that is developed by the
4 Office of Management and Budget.

5 “(2) REPORT.—The Director shall transmit to
6 Congress a report on the results of the study con-
7 ducted under paragraph (1) within 1 year of the
8 date of enactment of this subsection.

9 “(e) GAO STUDY.—

10 “(1) STUDY.—The Comptroller General shall
11 conduct a study of the National Civilian Community
12 Corps program authorized under subtitle E of title
13 I.

14 “(2) COMPONENTS OF STUDY.—The study con-
15 ducted under paragraph (1) shall consist of—

16 “(A) a comprehensive examination of the
17 program;

18 “(B) an examination of the programs cost-
19 effectiveness, particularly in relation to other
20 comparable AmeriCorps service programs;

21 “(C) whether the program has data and
22 quantifiable measures to adequately assess the
23 program’s progress toward achieving its stra-
24 tegic goals;

1 “(D) a review of the Office of Management
2 and Budget’s 2005 Program Assessment Rat-
3 ing Tool assessment of the program; and

4 “(E) recommendations for future Congres-
5 sional treatment of the program, particularly
6 assessing whether the program is duplicative or
7 could be more efficiently managed.

8 “(3) SUBMISSION.—The results of the study
9 conducted under paragraph (1) shall be submitted
10 within 6 months of the date of enactment of this
11 subsection.”.
