RESOLUTION

Providing for the expenses of certain committees of the House of Representatives in the One Hundred Eleventh Congress.

1 *Resolved,*

1 **SECTION 1. COMMITTEE EXPENSES FOR THE ONE HUN-**
2 **DRED ELEVENTH CONGRESS.**

5 accounts of the House of Representatives, in accordance
6 with this primary expense resolution, not more than the

16 *pears and presents testimony at a hearing of the Committee*
17 *on House Administration held prior to such date to review*
18 *the committee's use of the amounts provided for in section*
19 *1 during the first session of the One Hundred Eleventh Con-*
20 *gress and to determine whether the amount specified in sub-*
21 *section (b) with respect to the committee should be updated*
22 *on the basis of the review.*
