**AMENDMENT TO H.R. 2410, AS REPORTED
OFFERED BY MR. MCCAUL OF TEXAS**

At the end of subtitle A of title XI, add the following:

1 **SEC. 11__.** **COMPREHENSIVE INTERAGENCY STRATEGY**
2 **AND IMPLEMENTATION PLAN FOR SUDAN.**

3 (a) **STRATEGY AND PLAN.**—Not later than 60 days
4 after the date of the enactment of this Act, the President
5 shall develop and transmit to the appropriate congressional
6 committees a comprehensive interagency strategy
7 and implementation plan, which may include a classified
8 annex, to address the ongoing and inter-related crises in
9 Sudan and advance United States national security and
10 humanitarian interests in Sudan, which shall include the
11 elements specified in subsection (e).

12 (b) **ELEMENTS.**—The comprehensive interagency
13 strategy and implementation plan required under subsection
14 (b) shall contain at least the following elements:

15 (1) Consistent with section 1127, a description
16 of a comprehensive policy toward Sudan which balances
17 United States interests in—

18 (A) resolving the conflict in Darfur;

1 (B) implementing the Comprehensive
2 Peace Agreement (CPA) and promoting peace
3 and stability in Southern Sudan;

4 (C) resolving long-standing conflicts in
5 Abyei, Blue Nile, and Southern Kordofan;

6 (D) advancing respect for democracy,
7 human rights, and religious freedom throughout
8 the country;

9 (E) addressing internal and regional secu-
10 rity; and

11 (F) combating Islamist extremism.

12 (2) Progress toward achieving the policy objec-
13 tives specified in paragraph (1), including—

14 (A) facilitating the full deployment and
15 freedom of movement of the hybrid United Na-
16 tions-African Union Mission in Darfur;

17 (B) ensuring access and security for hu-
18 manitarian organizations throughout the coun-
19 try including, as appropriate, those organiza-
20 tions that wrongfully have been expelled by the
21 Sudanese regime;

22 (C) promoting reconciliation within and
23 among disparate groups;

1 (D) advancing regional security and co-
2 operation while eliminating cross-border support
3 for armed insurgents;

4 (E) meeting the CPA benchmarks, includ-
5 ing preparations for the conduct of national
6 elections and referendum; and

7 (F) shutting down safe-havens for extrem-
8 ists who pose a threat to the national security
9 of the United States and its allies.

10 (3) A description of how United States assist-
11 ance will be used to achieve the objectives of United
12 States policy toward Sudan, including a financial
13 plan and description of resources, programming, and
14 management of United States foreign assistance to
15 Sudan and the criteria used to determine their
16 prioritization.

17 (4) An evaluation and description of additional
18 measures that will be taken to advance United
19 States policy, which may range from—

20 (A) application of multilateral sanctions by
21 the United Nations or regional allies, or expan-
22 sion of existing United States sanctions;

23 (B) imposition of a no-fly zone or other co-
24 ercive measures; or

1 (C) rapprochement with the Sudanese re-
2 gime or other diplomatic measures.

3 (5) A complete description of both the evalua-
4 tion process for reviewing and adjusting the strategy
5 and implementation as necessary, and measures of
6 effectiveness for the implementation of the strategy.

7 (e) UPDATES OF STRATEGY.—The President shall
8 transmit in writing to the appropriate congressional com-
9 mittees any updates of the comprehensive interagency
10 strategy and implementation plan required under sub-
11 section (b), as necessary.
