**AMENDMENT TO H.R. 2647, AS REPORTED
OFFERED BY MR. SKELTON OF MISSOURI**

Page 72, line 18, strike "(h)" and insert "(d)".

At the end of section 414 (page 122, after line 14),
add the following new subsection:

- 1 (c) CONFORMING AMENDMENT TO STATUTORY LIMITATION.—Section 10217(c)(2) of title 10, United States
- 2 Code, is amended by striking "1,950" and inserting
- 3 "2,541".

Page 260, lines 9 and 10, strike "by adding at the end the following new section" and insert "by inserting after section 235, as added by section 242(a) of this Act, the following new section".

Page 260, line 11, strike "235." and insert "236."

Page 262, before line 1, strike "235." and insert "236."

At the end of subtitle A of title X (page 323, after line 12), add the following new section:

1 **SEC. 1003. ADJUSTMENT OF CERTAIN AUTHORIZATIONS OF**
2 **APPROPRIATIONS.**

3 (a) AIR FORCE RESEARCH, DEVELOPMENT, TEST,
4 AND EVALUATION.—Funds authorized to be appropriated
5 in section 201(3) for research, development, test, and eval-
6 uation for the Air Force are reduced by \$2,900,000, to
7 be derived from sensors and near field communication
8 technologies.

9 (b) ARMY OPERATION AND MAINTENANCE.—Funds
10 authorized to be appropriated in section 301(1) for oper-
11 ation and maintenance for the Army are reduced by
12 \$18,000,000, to be derived from unobligated balances for
13 the Army in the amount of \$11,700,000 and fuel pur-
14 chases for the Army in the amount of \$6,300,000.

15 (c) NAVY OPERATION AND MAINTENANCE.—

16 (1) REDUCTION.—Funds authorized to be ap-
17 propriated in section 301(2) for operation and main-
18 tenance for the Navy are reduced by \$22,900,000 to
19 be derived from unobligated balances for the Navy
20 in the amount of \$11,700,000 and fuel purchases
21 for the Navy in the amount of \$11,200,000.

22 (2) AVAILABILITY.—Of the funds authorized to
23 be appropriated in section 301(2) for operation and
24 maintenance for the Navy for the purpose of Ship
25 Activations/Inactivations, \$6,000,000 shall be avail-

1 able for the Navy Ship Disposal—Carrier Demonstra-
2 tion Project

3 (d) MARINE CORPS OPERATION AND MAINTENANCE.—Funds authorized to be appropriated in section
4 NANCE.—Funds authorized to be appropriated in section
5 301(3) for operation and maintenance for the Marine
6 Corps are reduced by \$2,000,000, to be derived from un-
7 obligated balances for the Marine Corps in the amount
8 of \$1,100,000 and fuel purchases for the Marine Corps
9 in the amount of \$900,000.

10 (e) AIR FORCE OPERATION AND MAINTENANCE.—
11 Funds authorized to be appropriated in section 301(4) for
12 operation and maintenance for the Air Force are reduced
13 by \$25,000,000, to be derived from unobligated balances
14 for the Air Force in the amount of \$4,300,000 and fuel
15 purchases for the Air Force in the amount of
16 \$20,700,000.

17 (f) DEFENSE-WIDE OPERATION AND MAINTENANCE.—Funds authorized to be appropriated in section
18 NANCE.—Funds authorized to be appropriated in section
19 301(5) for operation and maintenance for Defense-wide
20 activities are reduced by \$5,200,000, to be derived from
21 unobligated balances for Defense-wide activities in the
22 amount of \$4,300,000 and fuel purchases for Defense-
23 wide activities in the amount of \$900,000.

24 (g) MILITARY PERSONNEL.—Funds authorized to be
25 appropriated in section 421 for military personnel ac-

1 counts are reduced by \$50,000,000, to be derived from
2 unobligated balances for military personnel accounts.

Page 345, line 16, strike "30 days" and insert "90
days".

Page 391, line 15, strike "the budget fiscal year"
and insert "subsequent fiscal years".

Strike section 1505 (page 493, beginning line 12)
and insert the following new section:

3 **SEC. 1505. NAVY AND MARINE CORPS PROCUREMENT.**

4 Funds are hereby authorized to be appropriated for
5 fiscal year 2010 for procurement accounts of the Navy and
6 Marine Corps in amounts as follows:

7 (1) For aircraft procurement, Navy,
8 \$916,553,000.

9 (2) For weapons procurement, Navy,
10 \$73,700,000.

11 (3) For ammunition procurement, Navy and
12 Marine Corps, \$710,780,000.

13 (4) For other procurement, Navy,
14 \$318,018,000.

15 (5) For procurement, Marine Corps,
16 \$1,164,445,000.
