

5. AN AMENDMENT TO BE OFFERED BY REPRESENTATIVE MURPHY, PATRICK OF PENNSYLVANIA OR HIS DESIGNEE, DEBATABLE FOR 10 MINUTES

**AMENDMENT TO H.R. 5175, AS REPORTED  
OFFERED BY MR. PATRICK MURPHY OF  
PENNSYLVANIA**

In section 318(e) of the Federal Election Campaign Act of 1971, as proposed to be added by section 214(b)(2) of the bill, strike paragraphs (2) and (3) and insert the following:

1           “(2) INDIVIDUAL DISCLOSURE STATEMENT DE-  
2           SCRIBED.—The individual disclosure statement de-  
3           scribed in this paragraph is the following: ‘I am  
4           \_\_\_\_\_, of \_\_\_\_\_,  
5           \_\_\_\_\_, and I approve this message.’,  
6           with—

7           “(A) the first blank filled in with the name  
8           of the applicable individual;

9           “(B) the second blank filled in with the  
10          local jurisdiction in which the applicable indi-  
11          vidual resides; and

12          “(C) the third blank filled in with the  
13          State in which the applicable individual resides.

14          “(3) ORGANIZATIONAL DISCLOSURE STATE-  
15          MENT DESCRIBED.—The organizational disclosure  
16          statement described in this paragraph is the fol-

1       lowing: 'I am \_\_\_\_\_, the \_\_\_\_\_  
2       of \_\_\_\_\_, located in \_\_\_\_\_,  
3       \_\_\_\_\_, and \_\_\_\_\_ approves  
4       this message.', with—

5               “(A) the first blank to be filled in with the  
6       name of the applicable individual;

7               “(B) the second blank to be filled in with  
8       the title of the applicable individual;

9               “(C) the third blank to be filled in with the  
10       name of the organization or other person pay-  
11       ing for the communication;

12               “(D) the fourth blank to be filled in with  
13       the local jurisdiction in which such organiza-  
14       tion’s or person’s principal office is located;

15               “(E) the fifth blank to be filled in with the  
16       State in which such organization’s or person’s  
17       principal office is located; and

18               “(F) the sixth blank to be filled in with the  
19       name of such organization or person.”.

In section 318(e)(4) of the Federal Election Cam-  
paign Act of 1971, as proposed to be added by section  
214(b)(2) of the bill, strike subparagraphs (A) and (B)  
and insert the following:

20               “(A) STATEMENT IF SIGNIFICANT FUNDER  
21       IS AN INDIVIDUAL.—If the significant funder of

1 a communication paid for in whole or in part  
2 with a payment which is treated as a disburse-  
3 ment by a covered organization for campaign-  
4 related activity under section 325 is an indi-  
5 vidual, the significant funder disclosure state-  
6 ment described in this paragraph is the fol-  
7 lowing: 'I am \_\_\_\_\_, of  
8 \_\_\_\_\_, \_\_\_\_\_. I helped to  
9 pay for this message, and I approve it.', with—

10 "(i) the first blank filled in with the  
11 name of the applicable individual;

12 "(ii) the second blank filled in with  
13 the local jurisdiction in which the applica-  
14 ble individual resides; and

15 "(iii) the third blank filled in with the  
16 State in which the applicable individual re-  
17 sides.

18 "(B) STATEMENT IF SIGNIFICANT FUNDER  
19 IS NOT AN INDIVIDUAL.—If the significant  
20 funder of a communication paid for in whole or  
21 in part with a payment which is treated as a  
22 disbursement by a covered organization for  
23 campaign-related activity under section 325 is  
24 not an individual, the significant funder dislo-  
25 sure statement described in this paragraph is

1           the following: 'I am \_\_\_\_\_, the  
2           \_\_\_\_\_ of \_\_\_\_\_, located  
3           in \_\_\_\_\_,  
4           \_\_\_\_\_ helped to pay for this mes-  
5           sage, and \_\_\_\_\_ approves it.', with—

6                       “(i) the first blank to be filled in with  
7                       the name of the applicable individual;

8                       “(ii) the second blank to be filled in  
9                       with the title of the applicable individual;

10                      “(iii) the third blank to be filled in  
11                      with the name of the significant funder of  
12                      the communication;

13                      “(iv) the fourth blank to be filled in  
14                      with the local jurisdiction in which the sig-  
15                      nificant funder’s principal office is located;

16                      “(v) the fifth blank to be filled in with  
17                      the State in which the significant funder’s  
18                      principal office is located; and

19                      “(vi) the sixth and seventh blank each  
20                      to be filled in with the name of the signifi-  
21                      cant funder of the communication.”.

        In section 318(e)(5) of the Federal Election Cam-  
        paign Act of 1971, as proposed to be added by section  
        214(b)(2) of the bill—

(1) in subparagraph (A), strike “provided;” and insert “provided and the local jurisdiction and State in which each such person lives (in the case of a person who is an individual) or is located (in the case of any other person);”; and

(2) in subparagraph (B), striking “provided.” and insert “provided and the local jurisdiction and State in which each such person lives (in the case of a person who is an individual) or is located (in the case of any other person).”.
