The Committee on Rules, having had under consideration House Resolution \_\_\_, by a record vote of 7 to 4, report the same to the House with the recommendation that the resolution be adopted.

SUMMARY OF PROVISIONS OF THE RESOLUTION

The resolution provides for consideration of H.R. 4281, the Surface Transportation Extension Act of 2012, under a closed rule. The resolution provides one hour of debate equally divided and controlled by the chair and ranking minority member of the Committee on Transportation and Infrastructure. The resolution waives all points of order against consideration of the bill. The resolution provides that the bill shall be considered as read. The resolution waives all points of order against provisions in the bill. The resolution provides one motion to recommit.

Section 2 of the resolution waives clause 6(a) of rule XIII, requiring a two-thirds vote to consider a report from the Committee on Rules on the same day it is presented to the House, with respect to any resolution reported on the legislative day of March 29, 2012, providing for consideration or disposition of a measure extending expiring surface transportation authority.

## EXPLANATION OF WAIVERS

The waiver of all points of order against consideration of the bill includes a waiver of clause 11 of rule XXI, prohibiting the consideration of an unreported bill or joint resolution until the third calendar day on which it has been available.

Although the resolution waives all points of order against provisions in the bill, the Committee is not aware of any points of order. The waiver is prophylactic in nature.

## COMMITTEE VOTES

The results of each record vote on an amendment or motion to report, together with the names of those voting for and against, are printed below:

### Rules Committee Record Vote No. 206

Motion by Mr. McGovern to make in order and provide the appropriate waivers for amendment #1, offered by Rep. Rahall II (WV), Rep. Bishop (NY), Rep. Brown (FL), and Rep. DeFazio (OR), which would provide a total of \$109 billion in funding for FY 2012 and FY 2013 for reformed and restructured Federal highway, highway safety, and public transportation programs. Would offset the highway, transit, and highway safety programs authorized by the bill in FY 2012 and 2013, and allows the USDOT to maintain a positive balance in both the highway and transit accounts of the Trust Fund at the end of the bill.
