OFFERED BY MR. ROTHFUS OF PENNSYLVANIA

Page 12, after line 19, insert the following (and re-designate accordingly):

1 “(17) ‘negative-impact on jobs and wages rule’
2 means any rule that the agency that made the rule
3 or the Administrator of the Office of Information
4 and Regulatory Affairs determines is likely to—

5 “(A) in one or more sectors of the economy
6 that has a 6-digit code under the North Amer-
7 ican Industry Classification System, reduce em-
8 ployment not related to new regulatory compli-
9 ance by 1 percent or more annually during the
10 1-year, 5-year, or 10-year period after imple-
11 mentation;

12 “(B) in one or more sectors of the econ-
13 omy that has a 6-digit code under the North
14 American Industry Classification System, re-
15 duce average weekly wages for employment not
16 related to new regulatory compliance by 1 per-
17 cent or more annually during the 1-year, 5-
18 year, or 10-year period after implementation;

1 “(C) in any industry area (as such term is
2 defined in the Current Population Survey con-
3 ducted by the Bureau of Labor Statistics) in
4 which the most recent annual unemployment
5 rate for the industry area is greater than 5 per-
6 cent, as determined by the Bureau of Labor
7 Statistics in the Current Population Survey, re-
8 duce employment not related to new regulatory
9 compliance during the first year after imple-
10 mentation; or

11 “(D) in any industry area in which the Bu-
12 reau of Labor Statistics projects in the Occupa-
13 tional Employment Statistics program that the
14 employment level will decrease by 1 percent or
15 more, further reduce employment not related to
16 new regulatory compliance during the first year
17 after implementation;”.

Page 16, line 16, insert after “domestic jobs),” the following: “wages,”.

Page 16, line 25, insert after “HIGH-IMPACT RULES” the following: “NEGATIVE-IMPACT ON JOBS AND WAGES RULES,”.

Page 17, line 2, strike “a major rule or high-impact rule” and insert the following: “a major rule, a high-impact rule, a negative-impact on jobs and wages rule,”.

Page 29, line 13, strike “and”.

Page 29, line 14, strike “major rule or high-impact rule,” and insert the following: “major rule, high-impact rule, or negative-impact on jobs and wages rule,”.

Page 30, line 2, strike the period at the end and insert “; and”.

Page 30, after line 2, insert the following:

1 “(H) for any negative-impact on jobs and
2 wages rule, a statement that the head of the
3 agency that made the rule approved the rule
4 knowing about the findings and determination
5 of the agency or the Administrator of the Office
6 of Information and Regulatory Affairs that
7 qualified the rule as a negative impact on jobs
8 and wages rule.”.
