Mr. WOODALL, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 5461) to require the Secretary of the Treasury to submit a report to the appropriate congressional committees on the estimated total assets under direct or indirect control by certain senior Iranian leaders and other figures, and for other purposes.

- 1 *Resolved*, That at any time after adoption of this reso-
- 2 lution the Speaker may, pursuant to clause 2(b) of rule
- 3 XVIII, declare the House resolved into the Committee of

1 the Whole House on the state of the Union for consider-
2 ation of the bill (H.R. 5461) to require the Secretary of
3 the Treasury to submit a report to the appropriate con-
4 gressional committees on the estimated total assets under
5 direct or indirect control by certain senior Iranian leaders
6 and other figures, and for other purposes. The first read-
7 ing of the bill shall be dispensed with. All points of order
8 against consideration of the bill are waived. General de-
9 bate shall be confined to the bill and shall not exceed one
10 hour equally divided and controlled by the chair and rank-
11 ing minority member of the Committee on Financial Serv-
12 ices. After general debate the bill shall be considered for
13 amendment under the five-minute rule. The bill shall be
14 considered as read. All points of order against provisions
15 in the bill are waived. No amendment to the bill shall be
16 in order except those printed in the report of the Com-
17 mittee on Rules accompanying this resolution. Each such
18 amendment may be offered only in the order printed in
19 the report, may be offered only by a Member designated
20 in the report, shall be considered as read, shall be debat-
21 able for the time specified in the report equally divided
22 and controlled by the proponent and an opponent, shall
23 not be subject to amendment, and shall not be subject to
24 a demand for division of the question in the House or in
25 the Committee of the Whole. All points of order against

1 such amendments are waived. At the conclusion of consid-
2 eration of the bill for amendment the Committee shall rise
3 and report the bill to the House with such amendments
4 as may have been adopted. The previous question shall
5 be considered as ordered on the bill and amendments
6 thereto to final passage without intervening motion except
7 one motion to recommit with or without instructions.
