

AMENDMENT TO H.R. 2122

OFFERED BY MR. DINGELL OF MICHIGAN, MR. OBERSTAR OF MINNESOTA, MR. STENHOLM OF TEXAS, MR. TANNER OF TENNESSEE, MR. CRAMER OF ALABAMA, OR MR. JOHN OF LOUISIANA

In section 931(c)(1) of title 18, United States Code, as proposed to be added by section 2(e)(1) of the bill, strike “indicates a willingness to accept” and insert “accepts”.

In section 931(c)(1)(B)(ii)(II) of title 18, United States Code, as proposed to be added by section 2(e)(1) of the bill, strike “72” and insert “24”.

In section 931(c)(2) of title 18, United States Code, as proposed to be added by section 2(e)(1) of the bill, strike subparagraph (B) and insert the following:

1 “(B) For any instant background check conducted at
2 a gun show, the time period stated in section
3 922(t)(1)(B)(ii) shall be 24 consecutive hours since the
4 licensee contacted the sytem, and notwithstanding any
5 other provision of this chapter, the system shall, in every
6 instance of a request for an instant background check

1 from a gun show, complete such check over instant checks
2 not originating from a gun show.

In section 931(d) of title 18, United States Code, as proposed to be added by section 2(c)(1) of the bill, strike “indicates a willingness to accept” and insert “accepts”.

At the end of section 3 of the bill, insert the following:

3 (c) DELIVERIES TO AVOID THEFT.—Section
4 922(a)(5) of title 18, United States Code, is amended—
5 (1) by striking “and (B)” and inserting “(B)”;
6 and
7 (2) by inserting “, and (C) firearms transfers
8 and business away from their business premises with
9 another licensee without regard to whether the busi-
10 ness is conducted in the State specified on the li-
11 cense of either licensee” before the semicolon at the
12 end.
13 (d) EFFECTIVE DATE.—The amendments made by
14 this section shall take effect 180 days after the date of
15 the enactment of this Act.

After section 3 of the bill, insert the following:

1 **SEC. ____ . PENALTIES FOR USING A LARGE CAPACITY AM-**
2 **MUNITION FEEDING DEVICE DURING A**
3 **CRIME OF VIOLENCE OR A DRUG TRAFFICK-**
4 **ING CRIME.**

5 (a) **IN GENERAL.**—Section 924(c) of title 18, United
6 States Code, is amended—

7 (1) in paragraph (1)(B)(i), by inserting “large
8 capacity ammunition feeding device,” after “short-
9 barreled rifle,”; and

10 (2) by adding at the end the following:

11 “(5) For purposes of this subsection, the term ‘large
12 capacity ammunition feeding device’ means a device as de-
13 fined in section 921(a)(31) regardless of the date it was
14 manufactured.”.

15 (b) **EFFECTIVE DATE.**—The amendments made by
16 this section shall take effect 180 days after the date of
17 the enactment of this Act.
